November 8, 2021

Under technology, Josh Brennon reported: working on installing the Boxlight ProColor 65" interactive boards; server in St. Paul crashed so St. Paul internet is running through Chetopa; ordered 2 servers, one for each campus; and found some cameras so we won't need to purchase as many.

Under principal reports, Ms. Paden reported: evaluations done; SITE council meeting was a success; FFA did well at the district horse judging contest, 8th out of 22 teams; math scores were surprisingly good on the ACT pretest; discussed IXL and Fastbridge interventions in collaboration; November 11 will be the Veterans Day program and grandparent's day; coaches evaluations will be done this week; and trying to get Shawn Hill for a leadership program. Keaton McCracken reported: interim testing scheduled; volleyball was sub-state runner-up and league champs; football was district runner-up; HS BB starts next week; weight room flooring is not coming in until January; mirrors are being donated; concessions is getting their hamburger donated; Veterans' program is Thursday; and Sonic donated cups and spoons for student snow cones.
